Fund assets will be invested according to the principle of long-term security and an adequate return on investment, while maintaining an optimum ratio between the growth of pension savings and risk assumed.

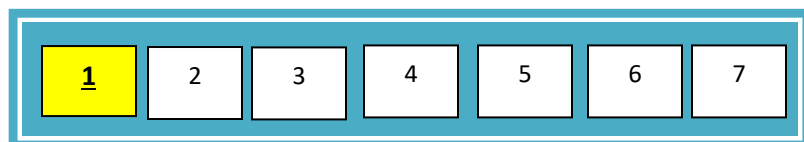
Raiffeisen INVEST intends to build a portfolio consisting primarily of long-term bonds (with maturities greater than one year) issued and guaranteed by the Government of the Republic of Albania

The fund is suitable for conservative clients, individuals and legal entities who have as priority the security of the investment assets of the Fund in relation to the profitability of the investment.

The fund is under the first risk category.

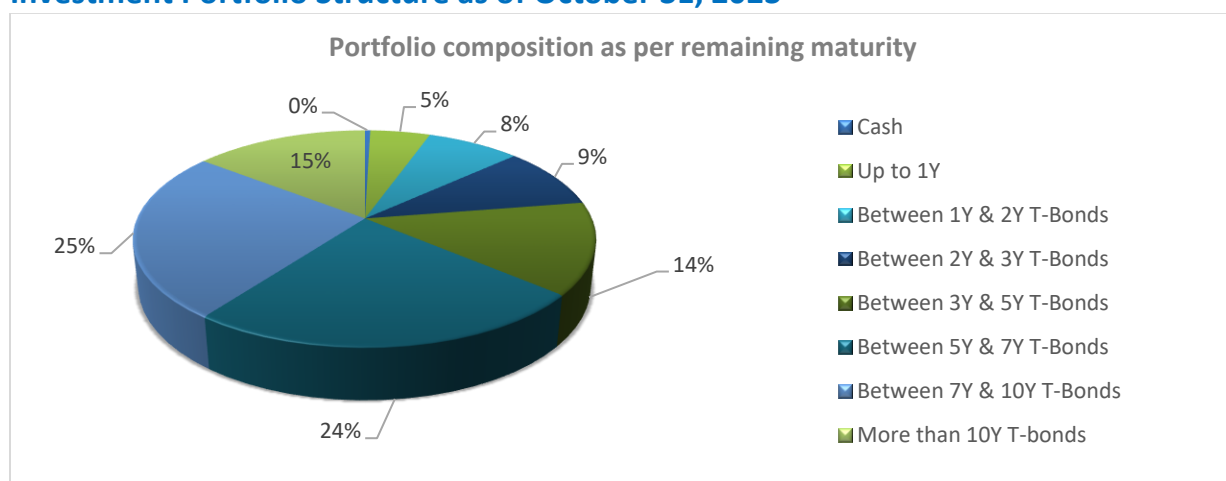
The synthetic risk and reward indicator corresponds to an integer, used to rank the Fund's risk profile on a scale of 1 to 7, based on increasing level of volatility. The lowest category does not mean that the investment is riskless. This indicator aims to offer the investor an overview of the fluctuations in Fund unit price based on historical performance. Historical data used to generate the indicator cannot constitute a guarantee on future risk profile.

In the framework of its investment policy, Pension fund invests in treasury bills and bonds issued by the government of Republic of Albania, taking into account the fact that trading activity in the fixed income secondary market is very limited.

Auctions of the securities issued in ALL from the Government of the Republic of Albania are relatively frequent: 12M Treasury Bills are issued twice a month; 2-year bonds once a month; 7 and 10-year bonds are issued on a quarterly basis. The government organizes the auctions of 5- and 3-year reference bonds with a frequency every 2 months, for each maturity. The investment strategy remains focused on long-term investments.

Net asset value is roughly ALL 1.36 billion as of October 31, 2023.

Developments and information on the performance of financial markets in October

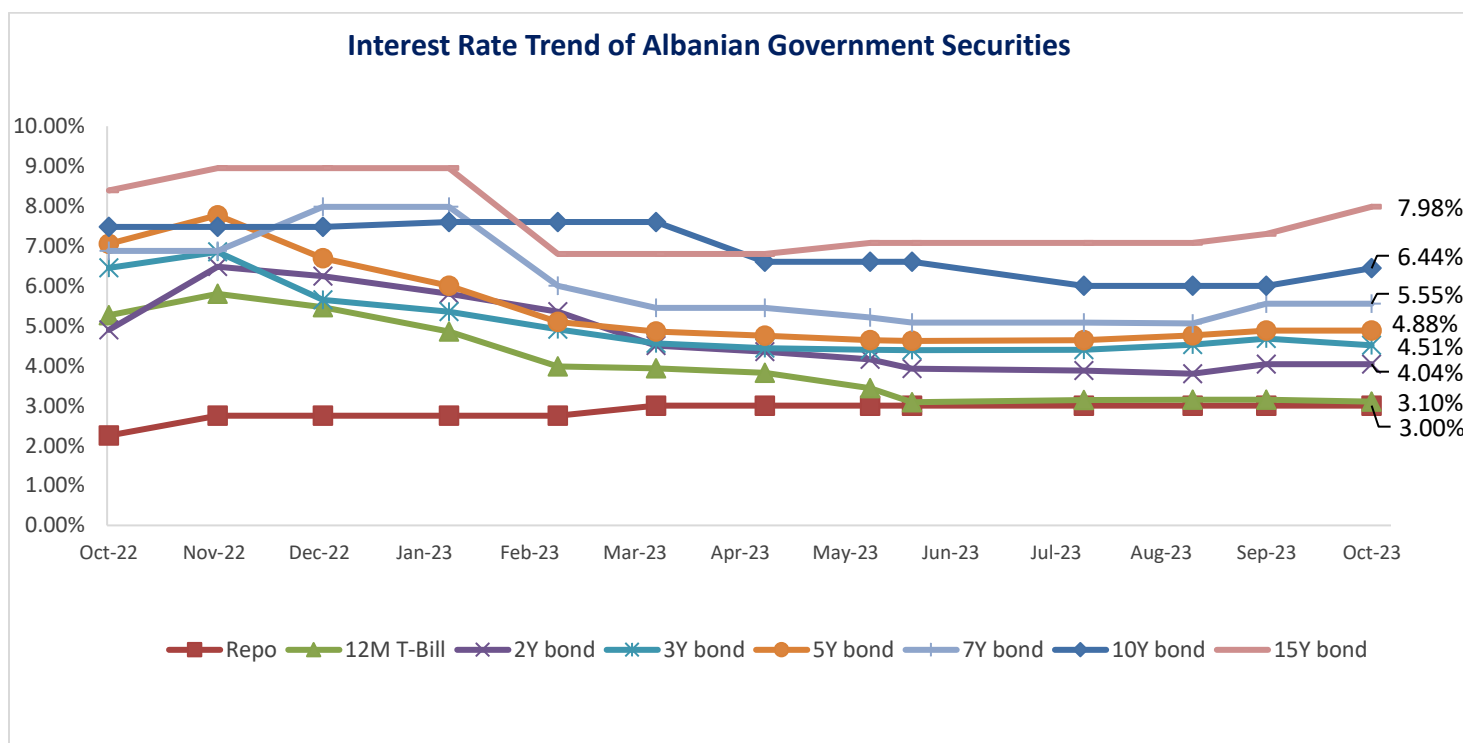
The assets of Pension Fund are invested only in T-bills and T-bonds issued by Albania Government and as a result the fund is exposed to changes in the interest rates of these securities. Thus, the Investments Funds are not directly related to international markets but are mainly affected by developments in the domestic market, such as changes in the interest rates of Albanian Government securities.

The treasury bills interest rates of Albania Government remained at the same levels during October, while the treasury bonds of Albania Government started to increase this month, after a generally downward trend during 2023.

During October, the yield of the 12 months Treasury Bill resulted at 3.103% decreasing by 0.05% compared to the auction rates in September.

Regarding the Treasury bonds auctions, the 10-years bond auction resulted at 6.44%, increasing with 0.44% compared to the last auction and the 15-years bond auction resulted at 7.98%, increasing with 0.68% compared to the last auction. The 5-years benchmark bond auction resulted at 5.113%, increasing with 0.171% compared to the last auction, while the 3-years benchmark bond auction resulted at 4.689%, slightly decreasing with 0.03% compared to the last auction. The rate increase was higher for long-term maturity bonds.

The chart below gives an overview of interest rate evolution of Treasury Bills and Bonds issued by the Albanian government during the 1-year period October 2022 – October 2023. For the 3 and 5 years reference bonds are presented the fixing yields, calculated from contributors' quotations at the end of October.



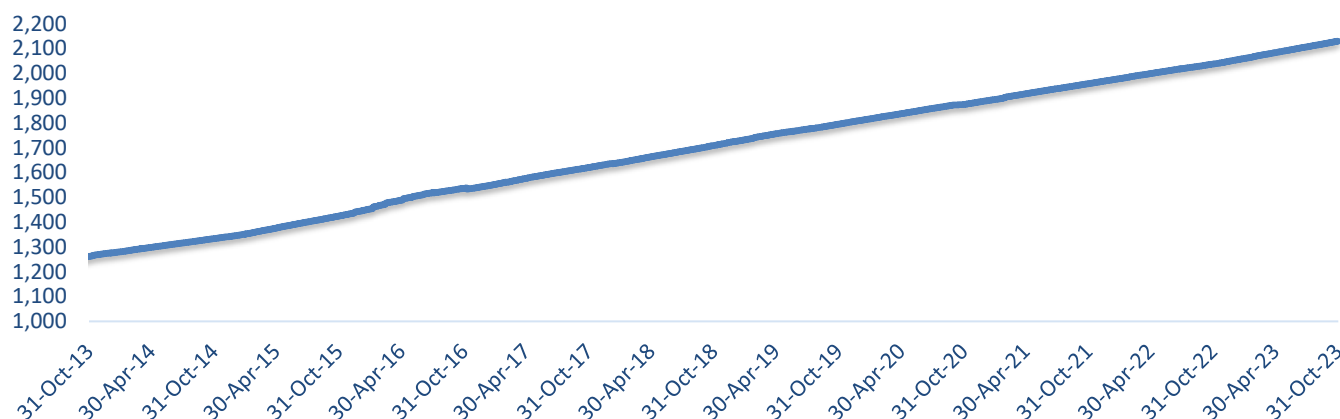
Fund Performance and unit value development October 31, 2023

Net annual return for the period 31 October 2022 – 31 October 2023 is 4.52%.

The unit value of Pension Fund has kept following an upward trend, increasing by **+0.37%** during the month of October.

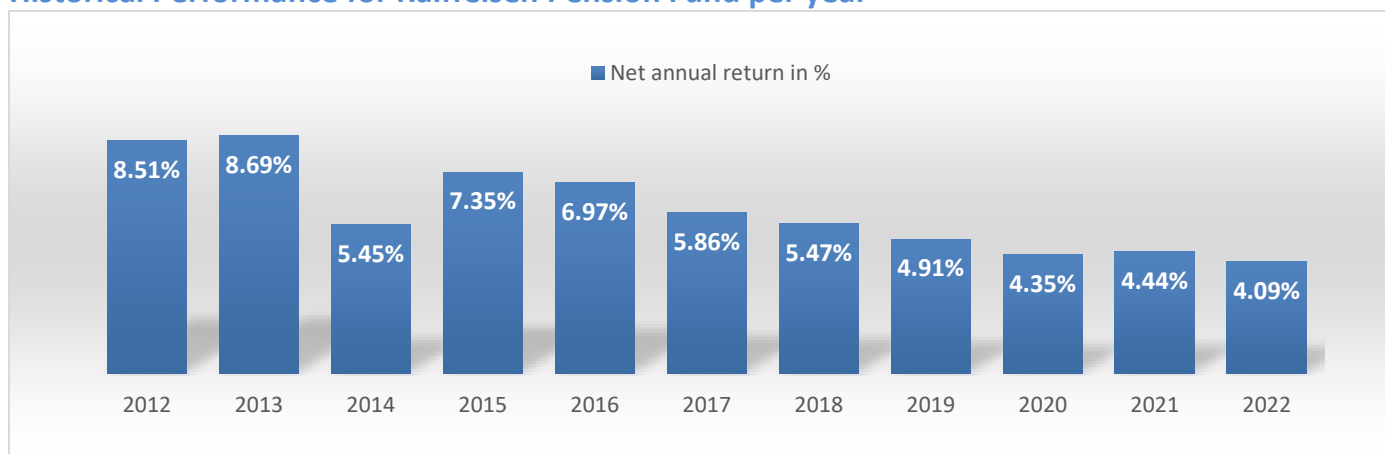
The net annual return is lower compared to the previous years because government securities interest rates, in which the fund invests, have been decreasing in the recent years. It should be taken into account that the return varies depending on market conditions, such as changes on the interest rates of Government securities.
