

The fund is under the first risk category.





#### Investment Portfolio Structure as of July 31, 2024



In the framework of its investment policy, Pension fund invests in treasury bills and bonds issued by the government of Republic of Albania, taking into account the fact that trading activity in the fixed income secondary market is very limited.

Auctions of the securities issued in ALL from the Government of the Republic of Albania are relatively frequent: 12M Treasury Bills are issued twice a month; 2-year bonds once a month; 7 and 10-year bonds are issued on a quarterly basis. The government organizes the auctions of 5- and 3-year reference bonds with a frequency every 2 months, for each maturity. The investment strategy remains focused on long-term investments.

Net asset value is roughly ALL 1.54 billion as of July 31, 2024.




#### Developments and information on the performance of financial markets in July

The assets of Pension Fund are invested only in T-bills and T-bonds issued by Albania Government and as a result the fund is exposed to changes in the interest rates of these securities. Thus, the Investments Funds are not directly related to international markets but are mainly affected by developments in the domestic market, such as changes in the interest rates of Albanian Government securities.

The Albanian Government securities interest rates have followed a downward trend during July. The yield of the 12 months Treasury Bill resulted at 3.193% decreasing by 0.08% compared to auction rate in June.

Regarding the treasury bonds, the 2-years bond auction resulted at 3.89% decreasing by 0.30% compared to the last auctions. The 3 and 5-years benchmark bond auction yield resulted at 4.095% and 4.881%, decreasing respectively by 0.08% and 0.05% compared to the last auctions. Also the auctions of 7 and 10 years bonds were organised and their yields resulted at 5.36% and 6.13% decreasing respectively by 0.14% and 0.23%.

The chart below gives an overview of interest rate evolution of Treasury Bills and Bonds issued by the Albanian government during the 1-year period July 2023 – July 2024. For the 3 and 5 years reference bonds are presented the fixing yields, calculated from contributors' quotations at the end of July.




#### Fund Performance and unit value development July 31, 2024

Net annual return for the period 31 July 2023 – 31 July 2024 is <u>4.55%</u>. The fund's 10-year return on an annual basis is 5.28%, while the return since launch is 5.98% on an annual basis.

The unit value of Pension Fund has kept following an upward trend, increasing by <u>+0.38%</u> during the month of July. The return of the fund depends on market conditions, such as changes in the interest rates of Government securities.

The increase in the Government securities interest rates will positively affect the performance of the Pension fund, which can invest at higher rates, increasing the return of the investment portfolio in the future.





# Historical Performance for Raiffeisen Privat Pension Fund per year
